

Kidz Luv Sports Inc. (KLS) is a non-profit organization that consists of parents/guardians of an athlete in a sport or a student in school. There is a President, Co-president, Vice-president and a Treasurer. The club was organized to promote, develop, supervise and voluntarily assist fundraising events for all members and help lower the out-of-pocket fees for sports and educational needs.

How do I become a member of Kidz Luv Sports? Is there a fee to join?

Visit our Website to fill out a membership form to be a member. Parents/Guardians are encouraged to become members as soon as the season begins or any time during the year. Our year runs from July to June. Membership fees are per Family annually. Membership fees will be taken out of the first paycheck you receive then annually in July. Membership fees cover various operating expenses that the club incurs.

What does Kidz Luv Sports (KLS) offer?

KLS offers many opportunities for fundraising throughout the season such as concession stands, food and beer carts at different venues like Mile High Stadium, Coors Field, CU Boulder, Dicks Sporting Goods Park, Fiddlers Green, CSU Fort Collins and Budweiser Event Centers. Fundraisers vary season to season.

How do I stay up-to-date on fundraisers?

KLS tries very hard to keep all members and potential members informed via Facebook, Website and communications by email. Please be sure that when signing up, KLS has your most current email address contact information.

Where does fund raised money go?

The KLS Treasurer will manage these funds. Each family will have an account and families can request a payout towards their child's sports fee or educational fees. Please be aware that it may take up to six to eight weeks before we receive a check from the venue. There is a minimum of three games that families need to complete before requesting a payout that is year to year. Families must also provide invoices/receipts.

How can members find out what their portion is?

As a paid member you will be given access to view your statement at any time through Facebook. If for any reason a parent/guardian needs to have a statement they may have a one time request or a statement from the treasurer. The statement will be emailed to the parent/guardian within 7 business days.

What costs can fund raised money cover?

Fund raised money typically goes towards lowering the cost of Sports or Educational related fees for example: Tuition, Books, College Housing, Competition fee, Team uniforms, Team camps, Team travel fees, Educational Tours, Hotel stay and much more! Please see our approved list or email the treasurer if you have a question.

What happens if there is money left in an account after the year is over?

Any money left in an account at the end of the year that shows no activity will rollover into the general fund. Members must show at least one activity on the account during the year otherwise, these funds roll over into the new KLS year (July) and the annual fee will be charged.

If a member decides not to renew his membership in July the member must send in a written letter or email to the treasurer and has 45 days to submit any receipts or invoices for a payout. Any unused balance will roll over into the general account. The general account goes towards operating expenses.

If a member decides to end their membership before the year is over, any fund raised money will not be reimbursed without any receipts. Additionally, if a member leaves at any time during a season, and leaves a balance in an account, and then decides to return at a later date, the balance will NOT be available and the member will have to sign up again for membership.
